Purchase of treasury shares

Bologna, 17 October 2013 - With reference to the press release of 8 August 2013, concerning, among other things, the beginning as from 12 August 2013 of the plan for the purchase of Unipol ordinary shares (the "**Shares**") to service the compensation plan based on financial instruments as approved by the Shareholders' Meeting of Unipol Gruppo Finanziario S.p.A. on 30 April 2013, notice is hereby given that, pursuant to and in accordance with Articles 87-*bis* of the Issuers' Regulation and 4, fourth paragraph, of the EU Commission Regulation No. 2273 of 2003, the Company – as a result of the resolution of the same Shareholders' Meeting – purchased 950,000 Shares on the regulated market at an average price of €3.9752 for a total amount of €3,776,443.47 on 11, 14 and 15 October 2013.

In accordance with the above mentioned provisions of law, please find attached hereto the detailed list of the individual purchase transactions, with information on the number, respective price and time of execution.

It is noted that, with the described transactions, the Company has ended the aforementioned treasury shares purchase plan, through the purchase of a total of 6,040,000 shares at an average price of €3.4437 for a total amount of €20,799,944.42.

At the present date, therefore, Unipol Gruppo Finanziario holds a total of 6,955,000 ordinary treasury shares, of which 6,740,000 directly and 215,000 indirectly through its subsidiaries Fondiaria-SAI S.p.A. (24,000), Milano Assicurazioni S.p.A. (16,000), and Unipol Assicurazioni S.p.A. (175,000).
