Purchase of treasury shares

Bologna, 19 September 2013 - With reference to the press release of 8 August 2013, concerning, among other things, the beginning as from 12 August 2013 of the plans for the purchase of Unipol ordinary shares (the **"Shares"**) to service the compensation plans based on financial instruments as approved by the Shareholders' Meetings of Unipol Gruppo Finanziario S.p.A. and its subsidiary Unipol Assicurazioni S.p.A., respectively on 30 April 2013 and 26 April 2012, pursuant to and in accordance with Articles 87-*bis* of the Issuers' Regulation and 4, fourth paragraph, of the EU Commission Regulation No. 2273 of 2003, notice is hereby given that:

- (i) Unipol Gruppo Finanziario S.p.A. – as a result of the shareholders' resolution approved on 30 April 2013 – purchased 1,040,000 Shares on the regulated market at an average price of €3.0718 for a total amount of €3,194,686.87 on 13, 16, 17, 18 and 19 September 2013.
- (ii) Unipol Assicurazioni S.p.A. - as a result of the shareholder's resolution approved on 8 August 2013 authorizing the purchase of shares of the parent company Unipol Gruppo Finanziario S.p.A. - purchased 175,000 Shares on the regulated market at an average price of €2.9479 for a total amount of €515,879.04 on 12 September 2013; in this regard, it is noted that Unipol Assicurazioni S.p.A. has ended the aforementioned purchase plan with the transaction described above.

In accordance with the above mentioned provisions of law, please find attached hereto detailed lists of the individual purchase transactions carried out by Unipol and by Unipol Assicurazioni S.p.A., with information on the number, respective price and time of execution.

At the present date, therefore, Unipol holds a total of 1,955,000 ordinary treasury shares, of which 1,740,000 directly and 215,000 indirectly through its subsidiaries Fondiaria-SAI S.p.A. (24,000), Milano Assicurazioni S.p.A. (16,000) and Unipol Assicurazioni S.p.A. (175,000).
