Publication of the offer document

Bologna, 5 April 2024 – Unipol Gruppo S.p.A. (the "**Offeror**") announces, pursuant to Article 38, paragraph 2, of the Issuers Regulation, that the offer document, approved by Consob with resolution No. 23052 of 27 March 2024 (the "**Offer Document**"), has been published today relating to the voluntary public tender offer (the "**Offer**") launched by the Offeror, pursuant to Article 102, paragraph 1 of the TUF, on all the ordinary shares (the "**Shares**") of UnipolSai Assicurazioni S.p.A. ("**UnipolSai**" or the "**Issuer**"), other than those already held, directly and indirectly, by the Offeror and the treasury Shares held, directly and indirectly, by UnipolSai.

The Offer Document was published today and made available to the public for consultation:

- (i) at the Offeror's registered office in Bologna, Via Stalingrado 45;
- (ii) at the Issuer's registered office in Bologna, Via Stalingrado 45;
- (iii) at the registered office of the intermediary in charge of coordinating the collection of acceptances (*i.e.* Equita SIM S.p.A.) and of the appointed intermediaries;

To assist certain readers, a courtesy English translation of the Offer Document will be published, it being understood that the Italian version of the Offer Document is the only official and binding document and shall prevail in any case over the English version.

Please note that attached to the Offer Document is the statement approved by the Issuer's Board of Directors pursuant to Article 103, paragraph 3, of the TUF and Article 39 of the Issuers Regulation, which includes the opinion of the Issuer's Independent Directors pursuant to Article 39-bis of the Issuers' Regulation.



The main elements of the Offer, as described in detail in the Offer Document, are set out below.

The Offer is promoted over a maximum of No. 418,788,217 UnipolSai Shares, in addition to a maximum of No. 4,622 UnipolSai Shares possibly granted under the performance share-based compensation plans.

The acceptance period for the Offer, agreed with Borsa Italiana, will commence at 8:30 a.m. (Italian time) on 8 April 2024 and will end at 5:30 p.m. (Italian time) on 26 April 2024 (extremes included) (the "**Acceptance Period**"), unless extended to be communicated to the market in accordance with the applicable law. Therefore, 26 April 2024 (without prejudice to any extensions of the Acceptance Period) will be the last day to tender to the Offer.

The Offeror will pay to each accepting shareholder a consideration equal to Euro 2.700 (*cum dividend, i.e.* including coupons relating to any dividends distributed by the Issuer) for each Share tendered to the Offer and purchased by the Offeror, which will be paid to each shareholder accepting the Offer during the Acceptance Period on the fourth trading day following the end of the Acceptance Period, *i.e.* on 3 May 2024 (subject to any extension of the Acceptance Period in accordance with applicable law).
